



SOUTH PARK MUSIC & ART FESTIVAL 2006

STREET FAIR, SEPTEMBER 9TH & 10TH

You are invited to be part of the Third Annual South Park Music and Art Festival Street Fair. As part of the South Park Music Festival, the Town of Fairplay blocks off the charming historical business district on Front Street and Park County provides the use of their Library Lawn and Gazebo for this artistically diversified all-ages event. The 2005 Festival was a smashing success with over 101 Musical Bands and 80 Colorado Artists, Businesses and Food Vendors. There was an estimated crowd of 11,000 in 2005; we expect a crowd of 15,000 in 2006.

Details will be released on our website at www.southparkmusic.com as the dates for the Festival nears, so check the site often for Vendor applications, Merchandise, VIP registration, Musician applications and Panel discussions.

Vendor Check-in will begin on Friday evening, September 8th from 6-8pm, then resuming on Saturday morning, September 9th between 7-11am. Vending hours are Noon to 6pm, Saturday and 10am to 6pm Sunday, September 10th. Vehicles must be out of the Festival area by 11am Saturday and re-entry is restricted to 6pm, Sunday. **NO EARLY TEAR-DOWNS.**

Each Vendor needs to bring their own tables and tents and are responsible for protecting their merchandise and displays from high winds, rain or snow. Limited security will be available, but please don't leave anything of value in your booth overnight. Requests for special needs will be provided, but there are a limited number of close-proximity parking spaces and this should be noted on your application. Please indicate your need for either 220 or 110 amperage, bring your electric cords and GFI adaptors.

Food Booths need to have all contact information included and if you are willing to stay open late on Friday, Saturday and Sunday nights, please let me know on your application. Closing time is at your discretion knowing that the Music continues till 1am.

Be aware that first time Food Vendors need to fill out an application for a Temporary Event Permit with Park County Environmental Health prior to the Event (I have this upon request) and ALL Food Vendors will be inspected during the Festival.

First time Artists are required to send or e-mail a one-page sampling, or brochure of their finished hand work, unless we have you already on file. Once the Jury accepts your artwork, you will be contacted. If you want your photos returned; please include a self-addressed, stamped envelope with your application.

Businesses, Returning Artists and Food Vendors are accepted once your check has cleared Town Hall. Non-Profits will get a verbal acceptance.

State of Colorado Tax Audit and Compliance forms, Special Sales Event Tax Returns and Out of State Special Event Tax forms are all available at Check-in if you do not already hold a Colorado Sales Tax License.

Sorry, but there will be no refunds for cancellations, late shows or early departures.
